Since our last pānui we have made it our priority to hui with our Whakatōhea whānau, both within the rohe and around the motu. In doing so we have been able to share the process of settlement with you and in turn receive your feedback in terms of aspirations for the settlement and beyond post settlement.

Within the rohe we have held Hui a Iwi at both Omarumutu and Terere Marae, hui at Waiaua Marae with Office of Treaty Settlements, presentations at the Ngāti Patu and Ngāti Ira monthly Hapū meetings as well as to the Opape Marae and Urupa Trustees. Around the motu we have met with whānau in Whakatane, Rotorua, Tauranga, Hamilton, Auckland and Wellington.

Te Roopu Awhina

Te Roopu Awhina has been established and is an advisory group that will sit alongside the Komiti Whiriwhiri Hitori, Kaumatua Committee, and the Whakatōhea Claimants Committee. Te Roopu Awhina will provide advice to the Whakatōhea Pre-Settlement Claims Trust and the Negotiators on specific opportunities in the Settlement. They will also contribute to the review of documents including relationship agreements and accords. The membership of Te Roopu Awhina is flexible and open to co-option of additional expertise covering the likes of Environment, Co-Governance, Local Government, Te Reo revitalisation, cultural regeneration, Resource Management, Post-settlement structures, tax, legal and commercial opportunities, economic development, small business, entrepreneurship, policy development, and education policy.
